1. Reference (a) requested us to review the NRRO situation and to advise and make recommendations to the Director for Defense, R&E, concerning our views on the extent to which the work already accomplished could be modified, adapted, or utilized to contribute to the intelligence program. Reference (b) stated our position regarding the usefulness for intelligence information of a completed NRRO.

2. As stated in reference (b), the type of information that could be provided by the NRRO could probably be obtained more readily and with greater consistency by other intelligence collection techniques which would have an earlier availability date. This position is still valid under the conditions of a modified or adapted NRRO Big Dish. Therefore, in my judgement, the NRRO's relatively

**MEMORANDUM FOR: Assistant Director for Defense
Research and Engineering
(Intelligence and Reconnaissance)**

**SUBJECT: CIA Interest in Naval Radio Research
Observatory (NRRO)**

1. This Agency has recently evaluated the NRRO for its usefulness in satisfying critical National Intelligence requirements. If the designed criteria are satisfied in the completed installation, it would provide useful intelligence information on Soviet electronic emitters. However, this same type of information can probably be obtained more readily and with greater consistency by other intelligence collection techniques which would have an earlier availability date. The primary advantage that the NRRO would have would be its immunity from political involvement.

2. Since this installation could have some potential contribution to U.S. intelligence, it would seem appropriate for the Intelligence Community to consider funding some of the operational costs when and if the installation is completed. However, its relatively poor competitive position vis-a-vis other collection systems would not warrant the allocation of significant intelligence funds for the construction of the installation.
