Dear Norman:

With reference to Mr. Runge's letter of 22 May 1962 concerning revising and updating the National Censorship Requirements Guide (U) published by the Department of Defense in May 1956, we are transmitting a copy of the Draft Requirements Guide workbook containing revisions by this Agency, which make this Guide current as of this date as it pertains to CIA.

CIA's contributions to the Guide are typed in red. These include new entries, suggested rewordings or additions, substitutions, or deletions. The following instructions have been typed in the left-hand margin: "Add," "Reword," "Substitute," "Delete," and "Add entire new page or heading." In the case of deletions, the printed designation "CIA" is crossed out in red. If a requirement already appears in the Guide and CIA is now interested in this type of material, the designation "CIA" is added in red.

Also transmitted is a copy of the "Alphabetical Index of Commodities on International Lists," the use of which is recommended to add to the present listing of strategic and critical materials in the Guide (pages E 1 - E 12). CIA believes that this Index is more representative of probable interests under sustained wartime conditions than shorter and more recent listings which reflect the cumulative effect of compromise between the United States and cooperating nations. It is not suggested that the list of strategic commodities under unilateral export control by the United States be included at this time.
