In view of the fact that Jim Angleton has accepted the DOD requirements for immediate processing, DIA will not anticipate direct access until around the middle of June. At that time, I will ask one of our CI types to get in touch with Jim in connection with follow-on interrogations concerning those DOD requirements that have not been satisfied at that point in time.

For your information, I have briefed General Fitch in general as to the importance of the Subject, and today will inform General Breitweiser and Admiral Lowrance of the basic reasons why this Subject has been handled as he has.

I appreciate very much having the problem explained to me, and both General Carroll and I are looking forward to our forthcoming meetings concerning the whole defector program.

In this connection, I am forwarding in the next few days a few ideas which, if implemented, I believe will materially benefit the program.

As you know, we are greatly concerned with the overall difficulty we are experiencing in the defector program, and in this case we suspect that the Subject has a great deal of information of security interest to the DOD.

In order that we might get together on the matter, Mrs. Dorothe K. Matlack (DIA Member, Interagency Defector Committee) has been appointed as the personal representative of the Director, Defense Intelligence Agency in meeting with representatives of your agency in finalizing arrangements for Defense direct access to [redacted] Mrs. Matlack will be assisted by Lieutenant Colonel Rea M. Pyle, Jr., and Major Earnest E. Livaditis.
