1. Attached is a first draft of a reply to the Killian Board's recommendations on tightening up of governmental security. We have been working on this within the Agency ever since receiving your memorandum but do not yet have an agreed position. In view of the deadline, we have sent copies of this to Mr. McNamara and Mr. Bush and the Attorney General as a first try to elicit their views. I know that Mr. McNamara has reservations and I feel reasonably certain that State will have some. I send this along to you in response to your telephone call as an indication of some of the things we have been thinking about.

2. It would appear that more study is necessary before we go forward with these proposals, and I trust that our suspense date can be postponed.
