1. Your Office has forwarded the USAF Plan For DOD-
Wide Advanced Training In Photographic, Radar and
Interpretation to the National Photographic Interpretation Center for comment. NPIC appreciates the opportunity to participate in the formulation of the training program and will submit comments and recommendations concerning the course context and other aspects of the program in the near future.

2. There is one aspect of the over-all plan which warrants consideration at this time, however, and that is the matter of finding a suitable location and space for the training activity within the Washington area. As you are aware, NPIC will move into its new specially designed and equipped facilities at the end of this calendar year, and the Director, NPIC, has suggested the possibility of making space available within these new quarters for the proposed training course.

3. I believe this proposal deserves your consideration and, rather than go into the details in this paper of the facilities which can be made available, I suggest that members of your staff meet with representatives of the Center to discuss this matter and conduct an on-site inspection of the facilities. Arrangements for such a meeting can be made directly through Mr. Lundahl's office,

SUBJECT: NPIC Comments on USAF Photographic Interpretation Training Program

1. The Secretary of Defense has assigned to the USAF the responsibility for developing and running a DOD-wide advanced training program in photographic, radar and [redacted] interpretation. A copy of this plan has been forwarded to NPIC for comment from General Breitweiser's office.

Since advanced training in these fields is of vital interest to the Center, and since we shall soon be moving into our excellent new quarters, it seems wise to me to offer the Air Force space within [redacted] This might well solve an Air Force problem of locating suitable space in the area, and at the same time permit us to keep fully abreast of this important program.


