[redacted] of your agency was assigned to temporary duty with my staff January last to undertake a group of related Air Force projects for which he is uniquely qualified. These projects have to do with the experimental application of some new technical and tactical techniques to the accomplishment of the Air Force mission.

2. It now appears that if the experimental program is successful, or even partially so, it may well contain elements suitable to [redacted] and therefore of interest to your agency. I shall see that the appropriate liaison is maintained.

3. [redacted] assignment originally was for 90 days, later extended by letter and informally by telephone as the program developed. It is difficult to assign a definite date for the completion of the program since it depends in part upon meteorological conditions and in part upon the ability of contractors to meet production dates.
