MEMORANDUM FOR: Deputy Director of Central Intelligence

SUBJECT : Contingency Fund for Fiscal Year 1964

1. This memorandum contains a recommendation for your approval. Such recommendation is contained in paragraph 4.

2. We have talked previously about the desirability of setting aside a contingency fund which will be available to fund new programs or aspects of programs which develop during the course of the fiscal year. Subject to your approval, I propose to establish such a fund in the amount of approximately [redacted] in

3. Attached is a memorandum prepared by the Budget Division which outlines a procedure for establishing this fund. In brief what we propose to do is to identify a number of projects or activities in the budget which will be deferred and only undertaken upon express approval of the DDCI. (A very tentative list of such items is attached for illustrative purposes.) This procedure will allow us to review and evaluate all new projects against the list of deferred projects before authorization by the DDCI to undertake either a deferred project or to initiate a new one.

4. If this procedure meets with your approval, we will prepare and submit the items for inclusion in the proposed list.
