MEMORANDUM FOR: Executive Director

SUBJECT : Inspector General Surveys of Development Projects  
Division and the Civil Air Transport (CAT)

1. In accordance with your request I have reviewed the reply of the Deputy Director (Plans) to our survey of the Development Projects Division. I have also reviewed the reply of the Deputy Director (Support) to the CAT survey. The DD/P reply, which was forwarded to me by your office, is returned herewith. For your convenience I am also attaching copies of the DD/S response to the CAT survey. I should appreciate it if the latter could be returned to this office when they have served your purposes.


2. On the basis of these reviews I recommend that the Director of Central Intelligence approve the original report, subject to the comments contained in the DD/P and DD/S responses, except as set forth in paragraphs 3 and 4, below. I recognize that recent organizational changes involving DPD will necessitate adjustments in their activities, and believe that objectives of the survey have generally been achieved. I am aware of the many improvements in CAT during the past few months, and believe that the problem areas are now under control. We will follow-up on this at the time of our next regularly scheduled inspection.

25X1 3. In Recommendation 19 it was proposed that an Executive  
Committee for [redacted] be established, consisting  
of senior representatives of the DD/P, the DD/S, and the General  
Counsel, to provide general policy recommendations and staff  
25X1 assistance in the management of [redacted]. The DD/P  
concurred in this recommendation, but suggested that the  
Comptroller be substituted for the DD/S. With recent organiza-  
tional changes I would agree that the Comptroller might be a  
member of this Committee, but do not believe that the DD/S could  
thereby be eliminated. In the larger projects the day-to-day  
responsibilities for logistics, security, training, communications,  
etc., are among the most important aspects of the activity. It

was the intent of the recommendation to establish a mechanism which could provide guidance and approval in the various areas of operational support. Since the recommendation also proposed that this Committee replace the FRC as the reviewing authority, it should be composed of the office heads themselves or their deputies. ]\*
