
SUBJECT: Comments on Inspector General's Survey of Cover Facilities

REFERENCE: Memorandum from the DCI to the DD/P, this Subject, dated 18 August 1955

A. General Comments

1. The report of the Inspector General's survey of cover facilities is a comprehensive and accurate reflection of the present status of Agency cover offices. It properly indicates that steps have been taken, since the general problem was assigned to its present responsible officer in October of 1954, to correct some of the deficiencies which had previously existed; and it also makes recommendations for further action, several of which were already underway at the time the survey was conducted.

2. The Inspector General's report places considerable stress
