MEMORANDUM FOR THE RECORD

SUBJECT: Meeting with DDCI on DD/R Fund Requirements

The DD/R requirement for approximately [redacted] to round out research programs in ORD and OEL was discussed with the DDCI on 1 May 1963. In addition to Gen. Carter, Dr. Scoville and Mr. Bross were present. After some consideration of the schedule annexed to the Comptroller's memorandum of 17 April 1963 on unbudgeted Agency fund requirements for FY 1963, the following decisions were reached:

a. [redacted] would be made available immediately to the DD/R.

b. DD/R should be allowed to reprogram within the programs under the jurisdiction of the DD/R, making available for example to ORD or OEL any surplus funds allotted to OSA.

c. DD/R will submit a program or project statement covering the research activities to be funded from the [redacted] and by reprogramming from other sources within the DD/R. This program statement would be submitted in terms of categories of activities with a statement of the objective of the activities, the amounts to be spent in each category and sufficient detail to convey an understanding of how the activity (contracts, etc.) relates to the declared objective.
