

MEMORANDUM FOR: Legislative Counsel

VIA : Inspector General

I am extremely embarrassed at the delay in your two offices in the handling of a letter dated February 17 from Congressman James C. Auchincloss. The draft reply to this letter reached my office on March 8, and was immediately dispatched, and then only after we had received a second letter from the Congressman, asking "to let me hear from you without further delay."

I wish an immediate investigation in your two offices, in concert, to determine the responsibility for the delay in handling this simple piece of correspondence. Also, I wish the Office of Legislative Counsel, as it refers mail to keep a careful check on the referral and to see that the office to which such mail is referred responds promptly.

I am now establishing a check, either in this office or in the Office of the Inspector General, of any Congressional mail that is referred, and strong measures will be taken if Congressional mail is not handled promptly and efficiently.



We are glad to know of your interest in our organization and shall give your application careful attention.


