MEMORANDUM FOR: Director of Central Intelligence

SUBJECT: Visit of Senators Frank Church, Frank E. Moss and Gale W. McGee

1. This memorandum is for the information of the Director of Central Intelligence.

2. Arrangements have been made for Senators Church, Moss and McGee to visit the Agency on Monday, 9 January 1961 at 4:00 P. M.

3. The scheduled itinerary for this congressional delegation is attached. The stated purpose of the trip was to observe the operation of the economic, technical assistance and exchange programs, leadership and student grant programs and to make estimates as to future needs. Senator McGee and Mr. Edward Kennedy joined the group in Africa. Donald Henderson, a Senate Foreign Relations Committee staff member and former Agency employee, accompanied the group. Through Senator McGee, an invitation was extended to the Senators to meet with Agency representatives wherever time would permit. We have received no reports of such contacts.

4. State and ICA reports indicate that the group was impressed with the need to train Africans to assume more responsible positions in the government and may have been alarmed at the likely loss of large numbers of expatriates over the next few months. Senator Church appeared to be more active than the others in the various briefings given by State and ICA and remarked that the more he saw of Africa, the more he was convinced that greater emphasis should be placed on the United Nations for technical assistance. He added his opinion that economic development would be a slow process in Africa.
