Dear Governor Almond:

On 28 July of this year I wrote to advise you that under the authority granted me by Section 255 of Title 40 of the U. S. Code, I accepted on behalf of the United States, limited jurisdiction ceded by the Commonwealth of Virginia under the provisions of Section 7-21 of the Code of Virginia (1950).

In addition, security considerations surrounding the work of the Central Intelligence Agency make it imperative that the United States have concurrent jurisdiction over crimes and offenses committed on our Langley property. Accordingly, there is transmitted herewith a Deed of Cession drawn up pursuant to the provisions of Section 7-24 of the Code of Virginia (1950). I would appreciate it if you and Attorney General Gray would execute this deed, assuring it to be in order, and return it to me for execution and recording in Fairfax County. After recording, we will return authenticated copies to you. Pending this action, you may wish to retain the enclosed extra copy.

Since we plan to begin moving into the new building about 15 August of this year, it would be appreciated if the Deed of Cession could be returned prior to that date. There is enclosed a self-addressed envelope for your convenience.

MEMORANDUM FOR: THE DIRECTOR





