



Meeting with Mrs. Patterson

At Mrs. Patterson's request I met with her today and delivered a copy of DCI's letter of 21 March to her.

She has been in touch with Walter Raleigh, Executive Director of the Young Presidents' Organization, to get him to include her "plan" on the agenda of a conference of that organization in Puerto Rico. April 12-16. Noting that the DCI is going to attend at least part of that conference, she wants to know whether he would be willing to participate in an informal off-the-record round-table discussion of the substance of her plan with selected members of the YPO.

I told her I would find out and let her know. I said I did not know what DCI's schedule is but I was sure that he would not want to discuss those aspects of her plan which have to do with its structuring within the U. S. Government. She said that it would be most satisfactory if he would be willing to discuss the general substance of her plan. At the risk of further obscuring an already very vague plan, I would say that she is trying to talk about the need for better U. S. psychological offensive in the cold war.

For your information she has recently talked (for seven minutes) with George McGhee in the State Department, Herbert Waters in ICA, and James Webb in NASA. Webb advised her to ask Mr. Caulkins of the Brookings Institute and Don Price at the Littauer School at Harvard to attend the YPO Conference in Puerto Rico.
