Dear Jim:

I was most pleasantly surprised to receive report and order of the board in Attorney General vs. American Comm. for Protection of Foreign Born.

Actually I was flattered that you remembered me. I had hoped to make the 35th reunion but circumstances prevented. On June 2nd the chairman of our board had a major operation for removal of the lower lobe of his left lung to remove a cancerous tumor. It was successful. I felt I should be here.

Haven't had time to finish reading your report but from several references it appears you were most thorough in your investigation. We need a great deal more of this good work. This country is practically an open book for spies. It is reported here that a year or so ago attaches of the Russian Embassy came to Tulsa and purchased aerial photographs of Tulsa and environs.



The Board did conclude that the Committee does meet the definition of a communist front organization and issued an order to the Committee to register as such under the federal law.
