Dear Mr. Dulles:

I am deeply grateful to you for the consideration you gave to my two recent letters.

However, my feeling of apprehension has not entirely dissolved. I have just read the statement made by Eudocio Ravines, identified as the founder of the Communist Party in Peru; and one by Dr. Emilio Portuondo, whom I am sure you know. Both suggest a conclusion of far graver situations in Latin America than you or General Cabell seem to find. I read the General's statement to the Congressional Committee and it was not altogether reassuring. He doesn't seem to feel that Castro is directly linked to the Communist movement -- which of course, is academic. But, he doesn't seem to view the situation in Cuba as allarmingly as I think the facts would indicate. He doesn't seem to be too well informed on the situation in Mexico. Frankly, I feel that unless something drastic is done about the strongholds being built up in Latin America by the Communist International we will, before my grandchildren arrive, be living in a Communist dictatorship. Our governments refusal to face the facts of Latin America is so astonishing to border on the unbelievable. The President's statement that he had faith in the people of Cuba overthrowing any Communism that might be down there is astonishing.

Undoubtedly, some of the actions of our government are based on intelligence which doesn't reveal the full ramifications of the penetration of Communism around us. I hope and pray I am mistaken about the degree of it's penetration.

Thank you again for the courtesy of your replies. Please do not bother to reply to this letter.
