Dear Mr. Green:

This will acknowledge receipt of your letter of 28 January concerning the late [redacted]. In regard to your 19 December letter, I sent you a reply on 30 January and you should now be in receipt of this letter.

I follow the general policy of not commenting one way or the other on the accuracy or inaccuracy of press, radio or other statements concerning the Central Intelligence Agency or my work. However, for your information, I did talk to [redacted] in December 1957 and he did not indicate to me that he had any information about Soviet espionage or about Soviet agents he wished to divulge. During this meeting, he did not indicate that he wished to have any further meetings with me, although he had ample opportunity to do so.
