MEMORANDUM FOR THE DIRECTOR

1. This memorandum recommends action in Paragraph 2.
2. It is recommended that the Director decline the speaking invitation from the Empire State Chamber of Commerce, Albany, N.Y., for their meeting in Washington, D.C., next May. (Letter of December 17 returned herewith.) Although the occasion and the locale have a degree of national significance, the dinner seems to be essentially a "State Society" type of event, and would probably not compete favorably (in terms of publicity) with other nation-wide prestige forums at which the Director has spoken in times past.
3. It is suggested that, if the Director does decline to speak, he might express a wish to attend this New York State dinner, in view of the very complimentary reference to Mr. Dulles, in Paragraph 4, as "the outstanding resident of New York State on the Washington scene," and the hint at "a special tribute" to be paid to Mr. Dulles on that occasion.
