While I have the responsibility for maintaining high standards in the employment of our personnel, I am sure you will understand it would not be appropriate for me to comment upon the individual cases that you mention or to describe in detail the various screening processes which are applied. I should also like to point out that this Agency did not come into being until 18 September 1947 when it was established by the National Security Act of 1947 and that [Redacted] was employed during World War II by another agency.
