


Your proposal for the establishment of a centralized automatic translation facility has been carefully reviewed both within the Central Intelligence Agency and in the forum of the Committee on Documentation of the U.S. Intelligence Board. We have concluded, without prejudice to what our position may be a year hence, that it would be premature to commit this Agency to the program you have outlined at this time.

We are, however, interested in the practical aspects of what your translation machine can produce now. We would like to ascertain first the feasibility of sending to you for a trial period of two months actual texts for translation on the machine. If this were possible, we would like to have answers to the following questions:

- a. What page volume of Russian texts could you accept during the trial period?
- b. Would you be able to handle the preparation of the texts for input to the machine, i.e., cutting the Flexowriter tape?
- c. What would be the cost (1) if you prepare the texts, or (2) if we make the preparation?


As we would propose to post-edit the text, only one copy of the machine translation would be required.

MEMORANDUM FOR: Director of Central Intelligence  
SUBJECT: Reply to IBM Proposal for Automatic Translation Facility  
REFERENCE: Letter from Dr. Piore to you, dated 20 April 1960 (attached)

This memorandum recommends action on the part of the DCI. Such recommendation is contained in paragraph 4 below.

1. The letter under reference and enclosures proposed the establishment of an automatic translation center at a cost of approximately [redacted] over a three year period.

2. This proposal was subjected to detailed analysis and discussion in the Committee on Documentation (CODIB) of the USIB, and by the CIA Advisory Committee on Mechanical Linguistics. The position of both of these bodies is that it would be premature to set up such a center now. There is insufficient evidence available to plan the parameters of an enterprise of this magnitude.

3. We do believe, however, that we should not close the door completely on the IBM proposal. We think that the responses to the questions we have posed will help us accumulate the data base on which planning can be predicated.

4. We recommend that you sign the attached letter to Dr. Piore. The wording of the letter has been coordinated with the CIA Advisory Committee on Mechanical Linguistics and has the unanimous approval of that body.

Dr. Piore has asked me to answer Mr. Dulles' letter of 9 July 1960, replying to our proposal for an Automatic Translation Facility. In this letter, Mr. Dulles raises the question of translation for a trial period of two months actual texts.


From the beginning of the year we have been processing arbitrary texts in all disciplines, brought to us by various interested parties, and the results have been made generally available. The Department of the Air Force has found these results satisfactory for this stage of development, and are convinced it can be sufficiently improved to meet the principle objective, of procuring intelligence by machine.

We are currently negotiating with USAF a program to continue processing actual text, specifically "Herald of Air Fleet" and "Civil Aviation", not for the purpose of evaluating the linguistics - as we know that can be improved - but to see what intelligence can be obtained with the developing state of the art.

Since the Government funded portion of our program is under the sponsorship of the Department of the Air Force, and as it is more convenient at this time to deal with only one agency, may I suggest you communicate with RADC if you wish to learn of the results of these studies or propose with them inclusion of your textual material.


