Dear Mr. Dulles:

I have given considerable thought to the ideological conflict which we are currently calling the "cold war". Apparently, the conflict seems to be the ideas of capitalism versus communism and socialism. I would like to offer you these thoughts for your consideration:

My belief is that the capitalism and imperialism as Marx envisioned it actually ended before Marx was born. My reason for making that statement is that historically capitalists seem to have been (1) a small group (nobility and/or industrialists) (2) who controlled a country's government (3) and controlled a country's wealth and (4) the small group had the ~~political~~ ^{political} and economic power to use a country's army to subdue the less developed nations of Africa, Asia, and South America, hence capitalists became imperialists. Since the wealth that was controlled by capitalists was logically inherited in family lines and titles of nobility were ~~given~~ ^{given} to the wealthy, the capitalists, in effect, had a political, economic, and social monopoly in the European countries.

Our forefathers who established our political, economic, and social system came from capitalistic and imperialistic countries of Europe. It ~~seems~~ ^{when} that ~~when~~ they aimed "to form a more perfect union" that they aimed to destroy the political, economic, and social monopolies that the capitalistic and imperialistic classes of Europe enjoyed. Logically, democracy gives control of the government to the people, and the people retain complete control by the vote, impeachment, or executive removal. Free enterprise gives the people ~~the~~ ^{the} control of the wealth by guaranteeing the right of freedom to invent, to hold patents, and make contracts. Congress and the courts control social policies and all authority there is subject to the people by vote or impeachment.

The ideas such as communism, socialism, fascism, Nazism, and land reform(?) and the like only substitute the powers of capitalists and imperialists (control of the government and the wealth) to the totalitarians. Democracy and free enterprise in combination cure the capitalistic monopolies and are really an/improvement and advancement over old-fashioned capitalism totalitarian and/substitutes for capitalism.

In the past two years I have written a play entitled Rich Communist, Poor Russians and a book (anti-socialism) entitled TOO CLOSE TO TYRANNY. Neither of the works was of ^{literary} quality for publication. I have spent ^{considerable} ~~considerable~~ time wondering if it would be in our nation's best interest to have information such as the above made public. I sincerely would appreciate your ^{advice} ~~opinion~~ on the matter.
