

Dear Mr. Valenti:

We are happy to accept your invitation to give the Space Strategy presentation to the Central Intelligence Agency.

The date of February 24, 1960 is convenient, and we will leave the time and place to your discretion. It is presumed it will be held somewhere in the Washington area.
