1. NEA Division's comments were sought on the material written by a [redacted] and submitted by Mrs. Hector to the Director.

2. The author puts up some tough-to-rebutt arguments. However, his idea that communism is not a matter of the stomach, of economic aid alone, but of ideas and philosophies, is well known. The alarm he rings to alert us to the possible loss of more states to the Communist Party of India before the elections in 1962 has long been heard.

3. He calls for "psychological warfare, a propaganda war against Communism, a battle for the minds of millions before the next elections...." As we await how he would deal with the situation, he merely says "This can be answered later at the proper time." He does suggest a close, careful, intelligent full-time study of the communists in action in India. This, needless to say, is going on. The author sounds as if he were suggesting he might be able to do it.
