

Dear Sir:

It was with some satisfaction that I read in the May 23 issue of U. S. NEWS AND WORLD REPORT that you are in the process of forming an, "Executive Reserve would be called upon to direct important phases of the defense effort."

In 1945 and 1946 for a period of one year I was Director of the Mail Room, American Embassy, Moscow, U.S.S.R. I resigned in order to return to the University of Texas to complete my degree work.

Mrs. Smith and I were teachers until our son was born in 1954. While I was in this work, I often felt that our school system should offer a one semester, senior course on AMERICAN FREEDOMS AND THE FRAUD OF COMMUNISM. A very good textbook, DEMOCRACY VERSUS COMMUNISM, was published in 1957 by D. Van Nostrand and Company.

Recently, I spoke with Dr. Edgar, Director of the Texas Education Agency, who said that he felt sure the Agency would approve this course and textbook if a superintendent were to request it. Dr. Irby Carruth, Superintendent of Austin Public Schools, was a visitor in the U.S.S.R. for one month in 1936. He made this observation while we were talking, "Most Americans have as little appreciation for their rights, liberties, and freedoms as they do for the air they breathe." All that I could add to this statement was AMEN.

We must teach our American youth to identify and study the "CANCER OF COMMUNISM." If this is not done, this growing CANCER cannot be successfully combatted.
