Mr. William Henderson, who has been Director of Meetings since 1952, has been appointed Assistant Executive Director of the Council, and Mr. Melvin Conant succeeds him in his former post.

The Council wishes to adapt its meetings program so far as possible to the needs of members for specialized information and analysis. 


