Dear Mr. Dulles:

I would like to take this opportunity to bring to your attention a recent outstanding performance of duty rendered by Colonel [redacted] [redacted] USAF, who is assigned to my staff in liaison capacity.

You will recall our conversations in Washington concerning the matter of counter-subversion and that Colonel [redacted] had represented CINCPAC at such a meeting in [redacted].
