Dear Governor McKeldin:

Recent newspaper articles concerning the acceleration of the construction of the Washington Circumferential Highway and Cabin John Bridge lead me to recall your exchange of correspondence with General Cabell in September 1956. As General Cabell said, we are intensely interested in the activities of the planning authorities in Maryland and Virginia and the Circumferential Highway and Cabin John Bridge are elements in the program that continue to be of primary interest to this agency.

I am sure you will be interested to know of the progress we are making with our new headquarters building. We have completed the clearing of the site and are now engaged in the grading of the roads and parking areas. We expect to have a contract this summer for the excavation and foundation work and our present schedule calls for the start of the building by the end of this calendar year. We plan to begin to occupy the building early in 1961.

Excellent progress is being made on the extension of the George Washington Memorial Parkway from Spout Run to our site. This extension is expected to be completed by the end of 1959. We also understand that surveys have been initiated looking toward the further extension of the Parkway from our building site to Cabin John Bridge.


