SUBJECT: IRC Report on Redefection

REFERENCE: Letter from Mr. Leo Cherne to the
Director, dated 27 March 1956, attached.

1. We have gone over the IRC report on the Communist redefection campaign among refugees from iron curtain countries, and find that from a substantive viewpoint it adds little or nothing to the knowledge or documentation already acquired by ICA in conducting its program for escapees. Indeed, parts of the IRC study seem to have been lifted intact from classified ICA [REDACTED] reports, and the study as a whole is characterized by its failure either to source the material presented, or to support its conclusions in a systematic manner. This is particularly true in its treatment of the problem of refugees in the United States who have returned to Eastern Europe. Very little data have been available from official sources on this particular aspect of the problem (ICA having been concerned solely with refugees in Europe), and the scarcity of official information is directly reflected in the IRC's failure satisfactorily to support its conviction that redefection among refugees located in the United States has become a problem of real magnitude. This conceivably may be the fact, but the IRC study doesn't establish it.

2. As you are aware, an OCB working group has been applying itself to a study of redefection for some time, and we understand it is about ready to come up with some recommendations which in many respects will parallel those of the Cherne study, particularly in regard to the handling of the problem in Europe, where Cherne and the OCB group were working from about the same material. However, in the case of redefectors from the United States, the OCB working group probably will not recommend courses of action involving further

publicity in the domestic press; the argument runs that no good can come of giving further dissemination to the Kremlin line. The IRC study, however, concludes that more publicity and a full mobilization of the departments of government able to contribute would be the best approach to a solution. The IRC report comments, in this context,
