
Dear Allen:

As you may possibly be aware, the Bureau of Far Eastern Affairs plans to hold its annual Chiefs of Mission Conference in Tokyo for three days beginning March 19. The primary purpose of such a conference is to provide a forum where the Far East Mission Chiefs can discuss with each other and with Bureau representatives from Washington problems of an over-all nature affecting our Far Eastern policies.

While the primary emphasis of the Conference will be on political problems, it is clear from the attached agenda that a number of subjects are slated for discussion in which you will have an interest. It has occurred to me, therefore, that you might find it useful to designate an observer to the Conference for CIA. Budgetary considerations, however, do not permit the Bureau to assume the necessary travel expenses involved.

In the event you decide to send such an observer to the Conference, it would be appreciated if you could provide us, as soon as possible, with the name of the person so designated.
