





Dear Mr. Dulles:

Dr. E. O. Lawrence heads a Task Force to look into the nuclear aspects of inspection as it relates to the formulation of a disarmament policy for the U.S. Together with his associates he asks if he may be briefed by CIA on industrial activities within the USSR with particular reference to the consumption of chemicals and power as they relate to the production of nuclear materials. The group is "Q" cleared and intends to be in Washington from September 12th through the 16th. A specific date can be provided on the arrival if this is convenient to you.
