

Dear Mr. Copley:

I was glad to have had the chance to talk to you the other day about the questions that were raised in your mind by the speech given by Endre Marton at the AP meeting. I hope that our discussion did help to clarify the situation.

I attach additional material that should be of interest to you. Let me call your particular attention to the report submitted to the Consultative Assembly of the Council of Europe which was unanimously approved by all members of the Special Committee of the Council that recently investigated Radio Free Europe on the spot in Munich. This report was made available to the European press in Strasbourg on May 2, but unfortunately has not received much attention in this country. It is a most thorough and careful analysis by an objective, representative and entirely non-American body, of the work of RFE. You might wish to send copies of this report to some of those who attended the AP meeting, in which event we could send extra copies to you.

Again my appreciation for the thoughtful attention you have been giving this complex and important question. I hope the conclusions you reach will be such as to encourage you in continuing the significant contribution you have been making to the success of the Crusade.
