Dear Bryce:

As a result of our recent meeting I thought you might be interested in having a list of congressional appearances by Agency representatives during the past year. These appearances were in executive session with a few minor exceptions. The list is enclosed and I would be glad to give you additional information on the nature of the appearances if you desire.

Except for Agency appearances before the Joint Committee on Atomic Energy, all requests for appearances before committees (other than Appropriations) are discussed with either the Chairman of the Senate Armed Services Committee or the Chairman of the House Armed Services Committee as the case may be. In the forthcoming year I would propose to adhere to the policy and procedure precedents as indicated. In the event of requests beyond this scope, I would wish to discuss the matter with you.

At the earliest opportunity I plan to carry through on the suggestion that I meet with Mr. Vinson to discuss the question of briefing congressional committees. That meeting would look toward a further discussion of the matter with Mr. Rayburn, Mr. Cannon, and probably Mr. Morgan. I also intend to go forward in a similar manner on the Senate side starting with a talk with Senator Russell and suggesting the desirability of further talks with Senators Johnson, Bridges, Hayden and, possibly, Mr. Dirksen.
