Dear Allen:

This is with reference to the NSC Action on U. S. policy on control of armaments taken at the meeting on January 6, 1958.

This action calls for two technical studies to be made by representatives of the Science Advisory Committee, Department of Defense, AEC, and the CIA. I have already discussed Department of Defense and AEC representation with Mr. Quarles and Admiral Strauss, and we have come to an agreement on the following panel compositions in their respective areas.
