Let me further state that it is my considered feeling that the Air Force is lacking, as all services are, in qualified personnel -- not so much at the top as at the working levels. It is very unfortunate to military services who are fully qualified.

Such problems as are presented by unthinking military personnel seem more inflated, to me, among the Air Force people. In speaking with a field grade army officer in the army intelligence service I learned much as to Air Force policy development. This military man was associated with Mr. Allen Dulles Central Intelligence Agency recently. I feel that he is well trained and qualified to speak as he did to me. Without violating secrecy he imparted lots of information as to the Air Force intelligence operation.

He had to work with corresponding officers in the Navy and the Air Force. In his particular phase he had wonderful cooperation from the Navy people, but had little cooperation from the Air Force people. His Air Force counterpart was turning in reports very contrary to the reports that the Navy and Army were developing. This army officer felt that the Air Force reports were rationalizations -- digging up facts and changing facts -- outright fudging -- in order to verify policy decisions that were already made. He felt that the Army and the Navy intelligence people were digging up the facts, interpreting them without bias and then placing them at the policy making level -- a straight line approach instead of the Air Force back door method. This army officer indicated that certain very critical information was distorted when it appeared in the intelligence briefing reports that appeared before senior Air Force officers at the policy making level.

He personally had great respect for the abilities of Allen Dulles, but not so much for the working staff. So often he found the C.I.A. investigators and evaluators ( or whatever the proper job title might be) were using the rationalization method rather than the straight line method.

He personally felt, without prejudice because of his army service, that the Army Intelligence and the Navy intelligence were the most reliable reporting and evaluating agencies maintained by this country. He felt that Air Force intelligence was almost a joke so far as he could tell. He felt that C.I.A. was necessary and, in the main, doing a good job but without as much coordination as was necessary. He felt Air Force was unnecessarily withholding very critical information from the other intelligence agencies.

This army officer felt there was nothing he could personally act upon because of his relatively junior status and because of his activity in this type of work and being on active military duty as a career officer.

He was disheartened by the apparent stupidity he found at the central level in Washington, particularly among Air Force intelligence.

I have every confidence in the ability of this army officer and in his opinions respecting this matter of poor intelligence service by the Air Force. Despite his willingness and ability to correct this matter were he in the right position, there is not a thing he can do at this time.

However, in bringing this matter to your attention, it could be referred to proper Congressional committees and they can carry it as far as necessary with the reservation that Congressmen, according to my informant, can never get into the entire intelligence picture, the jealousies and personalities involved.
