As you are aware, the Central Intelligence Agency, by statute, is precluded from the performance of any functions in the internal security field. Accordingly, we have confined our participation in this case to an effort to obtain evidence as to whether either is, or since his disappearance has been outside of the United States. To date, we have encountered no such evidence.

You may be assured that this Agency is actively working on this matter, and will continue to cooperate with the appropriate agencies who are working on the internal security aspects of the case.

I am in receipt of your letter of 23 May 1956 in which you inquire regarding action taken by the Central Intelligence Agency to establish the facts in the matter of the disappearance of [redacted] and with which you enclose copies of your exchange of correspondence with the Justice Department.

This Agency is aware of the facts which have been ascertained regarding the [redacted] disappearance from [redacted] and has considered the accusations, allegations, hypotheses and rumors which have attended this case. To date, we have encountered no evidence that [redacted] either is or, since his disappearance, has been outside the United States. Consequently, I am unable to report to you regarding the facts in this case. You may be assured that any evidence acquired by this Agency which concerns the case in question either will be conveyed to the appropriate United States agency or, if a foreign locale is involved, will be pursued by the facilities of this Agency in accordance with its assigned responsibilities.

This is in reply to your letter of April 18, 1956
urging investigation of the disappearance of [redacted]

STAT

The FBI states that this matter is being investigated
by the [redacted] Police Department which is keeping the FBI
informed as to the progress of the inquiry. According to the FBI
no evidence has been developed of the possible commission of a
federal offense which would authorize a separate investigation.
The FBI advises that it will follow the inquiry closely and will
take appropriate action in the event facts are developed indicating
federal jurisdiction.

As to your inquiry relating to an investigation by the
Central Intelligence Agency, the FBI is keeping the CIA currently
advised in the matter. Accordingly, it may be that you will want
to communicate with the CIA for further information.

Dear Mr. Attorney General:

I do not know whether there has been brought to your attention
the disappearance of [redacted]

[redacted] has been missing
since March 12 of this year and newspaper reports suggest that he has
been the victim of foul play. Moreover, it is strongly suggested by the
circumstances surrounding his disappearance, as reported in the press,
that the motive involved is political, based on the fact of [redacted]
avowed opposition to the Trujillo regime in the Dominican Republic.

I have met [redacted] on one or two occasions but know nothing
about him other than what I have read in the newspapers. It seems to me,
however, that this is a case into which the Justice Department should be
looking. If the FBI is not already investigating this situation, I strongly
urge that appropriate directions be given to the FBI. This case is one in
which our national and international interests and relationships may be
involved.

I would appreciate your advising me at an early date whether the
FBI has looked into the case, and if not, whether you find it possible to
direct the FBI to investigate [redacted] disappearance. Would there
be any other security agencies in the Federal Government for whom it might
be proper to investigate this case, under their statutory authority, such
as the CIA?
