MEMORANDUM FOR: The Director

SUBJECT: Attached Letter to Senator Clifford Case

1. It is recommended that the Director sign the attached letter to Senator Clifford Case.
2. We are suggesting an oral briefing in this case because it will permit a frank discussion with the Senator of the subject matter. I am advised by [redacted] represents an extreme right wing group which has given no evidence of effectual efforts to date. A representative of [redacted] Division attended a session at the Pentagon recently where the Colonel presented his case to officials of the Department of the Army. The U. S. Government representatives present have mutually concluded that, without questioning the Colonel's sincerity and purpose, his proposals are exceedingly vague and general in nature and represent nothing new. There does not appear to be any feasibility of developing a long range anti-Soviet undertaking around a nucleus of Czarist emigres. The Colonel is evidently seeking an audience with General Gavin, Deputy Chief of Staff of the Army, and would presumably like to have moral and financial support from the Government. It is unlikely that such an appointment will be arranged.
