Thank you for your letter of 18 February 1958 to Mr. Dulles concerning Mr. [redacted]

At the present time we do not have an opening in a position commensurate with Mr. [redacted]'s background and experience. In addition, we do not normally make appointments for direct assignment overseas. These factors, together with Mr. [redacted] desire for employment on a part-time basis, make it very unlikely that a suitable position would become available.

We were aware of Mr. [redacted]'s rather extensive travel abroad last year. Following his return to this country, one of our representatives visited him and discussed his trip with him.
