



Thank you for your letter of 18 August 1958 concerning Mr. [redacted]

[redacted] was interviewed in our personnel office on 29 August. He advised us that he was considering tentative employment offers from the International Cooperation Administration and from the Bureau of Printing and Engraving. He indicated he had special interest in the ICA offer but that there might be a delay of 90 to 120 days before a firm decision could be taken. In the meantime, he explained, he is interested in exploring other opportunities and thought he might qualify for work in intelligence research or economics.

Mr. [redacted] expressed the desire to do some refresher reading in the field of economics before participating in further interviews and agreed to call us when he felt prepared.
