

Thank you for your letter of 24 June 1958 concerning an inquiry which you received from Mr. [redacted]

When Mr. [redacted] was interviewed in the summer of 1957 and in January 1958, it appeared unlikely that we would have a position available for him but, as indicated in General Cabell's letter to you of 18 March 1958, we were glad to consider his application. Subsequently, Mr. [redacted] completed our application materials and his qualifications were reviewed against our current needs. While from time to time we have a requirement for applicants with advanced Russian language ability coupled with foreign area knowledge or an academic specialty, we do not have a current opening in which we could use a man of Mr. [redacted] particular qualifications.
