


Mr. Higgins is a well known attorney and would be happy to hear from you at the hospital and give you his reactions to the treatment he is receiving.



Dear Mr. Dulles:

The Board of Directors of the Woodrow Wilson Foundation has assumed the sponsorship for the collection, editing and publishing of the Papers and Letters of Woodrow Wilson. Dr. Arthur S. Link, foremost Wilsonian scholar in this country, has been appointed Editor in Chief and Dr. John Wells Davidson, another eminent Wilsonian, is the Associate Editor of this project. Work is already in progress at the Library of Congress.

This is a major task, historically and financially comparable to the publishing of the papers of Jefferson, Adams and other outstanding American statesmen. The Woodrow Wilson Foundation has authorized the John Price Jones Company to make a preliminary survey in connection with the financing of the project.

Mr. Charles A. Brecht and Mr. Emil R. Pohlars of the Jones Company would like to speak with you sometime during the next month to obtain your suggestions, ideas and opinions about the possibilities and problems of this undertaking.

It would be the greatest help to us if you could see either Mr. Brecht or Mr. Pohlars. They will let you know when they will be in Washington as soon as their travel arrangements have been completed.

This preliminary study will mean much in determining how to proceed with the project. We do hope that we may have the benefit of your advice.
