Dear Mr. Cummings:

We have been studying with interest the proposals put forward in your letter of 2 September 1959.

Frankly, I am in a difficult position with regard to the proposal, as up to the present time I have consistently declined to give any approval or sponsorship for TV or radio programs dealing with the Agency's activities and I am afraid that I will have to follow the same course in this particular case.

Naturally, the existence of the CIA is known and its various functions and there is no prohibition against mentioning it as the press does, even more frequently than I might wish. However, this is a free country and by and large the press and other media of publicity have in general been very understanding of our problems, which places us in a somewhat different situation than the Air National Guard and other more public and publicized organizations.

I know of the serious and effective character of your work and should welcome the opportunity of seeing you, if you should be in Washington.

Dear Mr. Cummings:

We have been studying with interest the proposals put forward in your letter of 2 September 1959. Your suggestion of a channel of instruction from the Central Intelligence Agency through the Air National Guard to the principal character is indeed an intriguing one; however, it poses certain difficult problems as far as we are concerned.

As you may know, a large portion of our responsibilities concerns activities outside the United States. Consequently, we are not in a very good position to offer advice or suggestions regarding these activities which would be useful to you. Having seen some of your programs, and knowing your reputation, I am sure that you would want these activities to have a touch of reality and a sense of conviction. At this particular time I am afraid we cannot help much in this regard.

It is quite possible that at some date in the future we might be able to work out something with you. I know that the theme of intelligence operations has a wide appeal, and can appreciate your interest in using it. We will bear in mind your thoughts in this regard and should the situation change, I can assure you that we will let you know. Thank you very much for writing me. I am sorry that we cannot be more helpful at the moment.


