Dear Mr. Dulles:

On Wednesday, September 23, the President's Committee on Government Employment Policy is planning to conduct a half-day conference for Federal administrators in the Washington area on the status and progress of the non-discrimination policy. The meeting will be devoted to a review of the policy over the past five years of its operation under Executive Order 10590 and a discussion of problems which still confront both the agencies and the Committee.

The conference will be held in the Congressional Room of the Willard Hotel, and will begin at 9:30 a. m. on September 23. The closing session will be a luncheon meeting in the South Ballroom of the Willard, at which Mr. Branch Rickey, the Committee's Vice Chairman, will be the speaker. The conference will close promptly at 2 p.m.

We would be honored by your presence should your busy schedule permit you to attend any or all of the discussions. Particularly, we request the attendance of your Employment Policy Officer, and others who might have a particular interest in the proceedings, such as higher administrative officers, personnel or employee relations officials, and training officers. We would like to have a minimum of two persons from each agency attending the conference, and we have room for additional personnel above this figure.

A copy of the agenda for the conference is enclosed. We plan an informal type of meeting, and we hope for a full and free discussion of the items.

We would appreciate having from your office no later than September 18 the names of those persons who will be representing your agency at the conference, with particular information as to whether or not they will be attending the luncheon session. The cost of the luncheon will be \$3.45 per person, and can be paid at the morning session or just prior to the luncheon session.
