

I want you to know how much I appreciate your letter of April 24 offering your assistance in the care of my brother.





Letter dated 24 April 1959, from Dr. Clara J. Fonti,   
 wherein writer states that:

- STAT
1. A few days before the abovementioned date she delivered to the US Consulate in Milan a copy of her book containing all her formulas and findings, which she has made available to the medical world.
  2. She immediately complied with the request of Dr. Mary Voornemau, who had informed her that she had been asked by Mr. Allen Dulles and Dr. Johns to seek writer's intervention in Secretary John F. Dulles' case.
  3. She does not know the patient's present state of health and, consequently, is unable to determine what, if any, therapy, may still prove beneficial to him.
  4. She is at the complete disposal of the physicians attending Secretary Dulles.
