
Dear Mr. Rosenblatt:



I am sending you this manuscript on suggestion from friends that you and your Agency are in a position to evaluate and perhaps endorse the principles contained therein, from a non-biased viewpoint.

This paper, which covers a broad scope, entails a unification theory for the Armed Forces without destroying the integrity of the separate branches of the military services.

Although approximately four-fifths of the manuscript is devoted primarily to military organization, predominantly in the scope of the Army, I have attempted to present our national position, from the standpoint affected by our domestic and foreign policies in relation to our military balances against the opposing empire...Soviet Union.

I would be encouraged to continue a sequence to this work, in the form of a diagnosis for field forces timetable operations, if your reaction and response is favorable.

May I hear from you soon?

Dear Mr. Rosenblatt:

Your manuscript entitled "Three Points" has been referred to this office by the Chief of Staff, U. S. Army for review. This work has been given a thorough review and it is quite evident that you have made an extensive study of communist ideology and strategy, and that you have devoted considerable thought to the political, geographical, economic and military aspects of a national strategy designed to put an end to the communist threat.

Although your "Three Point Policy" presents a different approach to the solution of one of our most difficult problems, the concept envisaged appears more properly to be a matter for discussion and review at the National Policy level. For this reason it is not considered appropriate for the Department of the Army to evaluate or comment on your manuscript.

Your interest in national affairs is commendable and your consideration in bringing your views to the Army's attention is greatly appreciated.
