

It has been a long time since we have talked, and I hope that things are going well, and especially that your son is getting along after his terrible experience in Korea. I have heard nothing about him for a long time. My own son, Anthony, is a Second Lieutenant in the Air Force and will get a change of duty from California to Washington this spring.

Both Tудie and I have undergone major surgery in the last twelve months, in my own case particularly serious, for last spring I was half way through the door before a very great surgeon brought me back. I am not yet fully recuperated.
