

Dear Allen:

This is in response to your letter of July 22 in which you request that the Foundation provide your agency with certain statistical data on U.S. scientific and technical professional manpower. The Foundation will, of course, do whatever it can to cooperate with your agency in this matter.

It should be pointed out, however, that the Foundation does not always have available information in the form you desire. For example, employees are not typically reported by level of training in surveys of employment in this country. Neither have we any accurate method of counting "college-level graduates employed at a level and in an activity appropriate to their training." In other ways, the reporting concepts employed in this country will not always match those used in the Soviet Union.

Mr. Thomas J. Mills (Code 178, Extension 372) will shortly get in touch with  to discuss the matter in further detail and arrange to provide you with what assistance we can.
