
**MEMORANDUM FOR: Chairman, Joint Chiefs of Staff**

1. Referenced plans were commented on informally by this Agency at the same time Service comments were being considered by the Joint Chiefs of Staff. The comments sent to the commanders by the JCS at the time the referenced plans were approved have also been considered by this Agency.

2. This memorandum is to advise you that with certain reservations as to operational concepts, these plans are acceptable to the Central Intelligence Agency. Specific reference is made to Appendix IV to Annex F to Operations 25X1



3. The Central Intelligence Agency within budgetary, personnel and operational limitations will do everything possible to fulfill specific requirements which may be forthcoming as a result of JCS approval of

these plans. However, the limitations mentioned in paragraph 2 above must be considered by the military in levying of requirements on this Agency. I have recently forwarded to you a suggestion concerning criteria to guide the establishment of military requirements on CIA. I am confident that after consideration of this statement and the further factors which are involved we can arrive at a mutual understanding concerning the scope and character of the CIA operational role in the field of Unconventional Warfare.
