

MEMORANDUM FOR: Executive Assistant to the Director  
SUBJECT: Admiral Byrd's Opinion on Possibility of Soviet Nuclear Explosion in Arctic

1. By a routing slip dated 15 June 1954, you transmitted a letter from the Director with the request that it be delivered [redacted] to Rear Admiral Richard E. Byrd, USN (Ret). At the same time you asked us to obtain Admiral Byrd's opinion as to whether it might be possible for the Soviets to explode a nuclear bomb in the Arctic region without detection.

2. We are attaching a memorandum [redacted] describing delivery of the letter and giving Admiral Byrd's opinion on polar regions as possible sites for Soviet nuclear explosions.
