

Dear Mr. Dulles,

You were so friendly to help me to come over to the United States this fall for a year under the Fulbright program. (I met you in 1949 with the Hambuechens in your home in Long Island and my wife met your wife in T schiertschen in the home of her sister Barbara Kempner. As I came through Washington, I tried to see you in your office, but unfortunately you could not receive me. I got a grant from the John Hays Whitney Foundation, which allows me to travel all over the Country so that my wish to see as much as possible of the United States which will me make able to write a book about the American Democracy which is my purpose to counteract many queer ideas the European have about America. The first semester I was teaching at Tulane University in New Orleans and I was very glad to see something of the South, most Europeans have not the possibility to study. But now for the second term I am finding it very necessary to stay at one of the old New England Universities and to see a lot of the Government and Congress in Washington and perhaps of the working, industrial and social conditions of the big cities. Considering these various purposes I came to the result that Princeton would be the best place, not so far from Washington and New York and Philadelphia and famous University of the New England World. I found no objections against this plan in a conversation with the secretary of the Whitney Foundation Mr. Samuel C. Park Jun. in New York, but my sponsor, Mrs. Lam from the Conference Board in Washington, which is the office of the State Department for the exchange program told me as I met her in the end of September in a hurry (she was going for some months to Europe, that this would not be possible. I could only get

the Whitney grant for the second term , if I would agree to go to a Southern university again or to a small college. As this information was against the information I got from Mr. Park , I wrote to Mr. Park and applied for an exception specially mentioned Princeton as the best place. Some weeks later I got the answer that he had submitted my application to the Board of trustees and that the Board of Trustees had discussed my problem and had him authorized to write to the Conference Board requesting that they re-examine my request for special consideration in planning my year in the United States . He added that his feeling was that the Conference Board would look with sympathy upon my request. So I had the impression that the Whitney Foundation had no objections against my plan with Princeton. But the Conference Board office wrote to me that nothing could be arranged before the return of Dr. Lam. Now Dr. Lam has returned , but wrote to me at the 18. Dec. , a letter I got after the holidays, that I could not get a grant of the Whitney Foundation, as I would not teach. I answered that this was a great mistake that I should like to teach as much as possible and that I had mentioned research work in all my letters expressively " beside teaching " This afternoon I got a telephone call from the same Lady, that a second term at a large University would be not possible , I had to go to a small college, which could be near Boston, New Haven or Baltimore. Under these circumstances I am in very bad situation because the time is now a very short one (not by my fault) and I can not understand, why Dr. Lam after the decision of the Board is so absolutely against Princeton or an other Place, in which I had to see a lot of American political life . I mentioned the Georgetown University , because I am a catholic and could there give the students who want to go in the foreign service something about the political situation in Europe as I did at Tulane. But Mrs . Lam was completely against this plan too. Perhaps she would agree with the Goucher Girls College in Baltimore. I would not object , because than I could find near ~~contact to John Hepkin~~

contact with John H. Hopkins and perhaps make an arrangement that I could stay some days in the week in Washington.

I write this letter to you because I could not find out what the situation is and if you could do something for clearing I should be very glad. I do not want to make any difficulty. But I am so convinced that I ~~may~~ might do a good work for both countries, Germany and United States with my studies that I will object to other plans, which will me bring out of contact with the most important subjects of my studies. I must concentrate my studies on Washington and New England in the next four months, because ~~I~~ can not stay in summer time in the East by causes of health. I want to go for the rest of my year to the Pacific coast.
