

On May 6th I wrote to the Honorable Henry A Byroade, with regard to the Eichmann matter, a copy of which I also sent to you, and to which I have not as yet received a reply. It surprised me greatly that I had not heard from Mr. Byroade considering the importance of the matter involved.

On June 25th I have again written to Mr. Byroade concerning this vital problem, a copy of which is enclosed herewith.

I would very much appreciate your assistance in attempting to learn and to advise me as to why he did not answer my letter.

Mr. John Raymond, Assistant Legal Adviser of Department of State, was kind enough to return the documents, pictures, etc., which I sent to your office. I was also disappointed in his reply. I cannot understand why this matter was referred to his office as I still feel that your department is the logical one to handle this matter properly to achieve the necessary results. Enclosed herewith you will find a copy of my letter to Mr. Byroade.

Thanking you again for your kindness and cooperation and anticipating your early and favorable response, I am,





I am in receipt of your letter stating that you gave all paraphernalia which I sent you on the Eichmann case to the Department of State.

Please be good enough to notify me as to whom you sent the information and to what division.

I cannot understand why the matter has been referred to another department. I have been in contact with Mr. Dulles for the past few years in reference to this case and feel it should be carried through to the end by the C.I.A. The entire Eichmann case is an issue of security not only for the United States but for the entire world.

My dear Rabbi Kalmanowitz:

This will acknowledge your letter of 18 May 1954 regarding the data on Adolf Eichmann which you sent me and which I forwarded to the Department of State. I have been advised that this matter is being handled in the Office of the Assistant Legal Advisor to the Department. I have further been advised that a reply from the Legal Advisor will be sent to you in the very near future.

You also stated in your letter that you cannot understand why this matter was referred to another department. May I again point out that the prosecution of Eichmann is not within the competency of the Central Intelligence Agency. The fields of national policy and representations to foreign governments are the primary responsibility of other departments of our government.
